SUBJECT: #19-024 – NORCOM Financial Participation 2020

Background

Each year Woodinville Fire & Rescue (the "District") receives notice from the North East King County Regional Public Safety Communication Agency ("NORCOM") advising participating agencies on the programs and objectives contained in NORCOM's proposed budget, changes in the User Fee formula, and the required financial participation for each Principal and Subscriber for the following year.

For 2020, participating agencies have been advised that there are no changes in the Calls for Service calculation. The 2020 budget takes into consideration a \$280,000 reduction of funding from the E-911 Program Office as well as an additional four full-time positions that have been added in NORCOM administrative functions for 2020. NORCOM is budgeting for a \$500,000 operating beginning fund balance to offset increases to user fees.

Fiscal Impact

The attached Revenue Detail for NORCOM's Operating Fund shows the District's 2020 allocation as \$184,216, a \$1,452 or 0.8 percent increase from the District's \$182,764 allocation in 2019. Staff is including a request for this amount in the District's 2020 budget.

Requested Action

As per the NORCOM Interlocal Agreement, to which the District is a party, the Board is required to provide NORCOM with a Resolution approving the District's allocation for NORCOM's budget.

Recommendation

Staff recommends that the Board adopt Resolution 2019-12, as presented.

The Finance Committee agrees with Staff's recommendation that the Board adopt Resolution 2019-12.

RE: 2020 Financial Participation

Pursuant to Section 12(c) of the NORCOM Inter-local Agreement, this notice advises Participating Agencies on the programs and objectives as contained in the proposed budget, of any changes in the User Fee formula, and of the required financial participation for each Principal and Subscriber for the following year.

This budget takes into consideration changes from outside revenue sources, particularly a \$280,000 reduction of funding from the E-911 Program Office. Four full-time equivalent positions have been added in NORCOM administrative functions for the 2020 fiscal year. NORCOM is budgeting for a \$500,000 operating beginning fund balance to offset increases to user fees.

One transfer will be made from the Operating Fund to the Operating Expense Reserve Fund in the amount of \$13,743. This transfer is required per current NORCOM policy.

The Rate Stabilization Fund will not be utilized in 2020 to reduce user fees.

This is in accordance with the summary budget document transmitted to the approved by the Governing Board on August 9, 2019.

There are no changes in the Calls for Service calculation.

In 2020, Woodinville Fire and Rescue will be assessed \$184,216. This amount is a \$1,452 or 0.8% increase from 2019 assessments.

Enclosed in the following pages are the required financial participation notification amounts for each Principal for fiscal year 2020, a comparison of agency fees for years 2017 to present, a comparison of "cost per call" for agencies from 2017 to present as well as a comparison of Principal rate calculations between 2019 and 2020.

SUBJECT: Fire Chief's Report – September 17, 2019

Fire Chief's Report/Activities

I am pleased to present the following summary of District activities since the Board's last regular meeting:

Incidents

The District responded to 386 incidents since your last regular meeting. There were four significant incidents. On August 21, we had a fire confined to a piece of machinery in a commercial business. We received automatic aid from Bothell, Kirkland, Redmond, and Northshore. The fire is being investigated by the King County Fire Marshal's Office. Also on August 21, 31's crews responded on a motor vehicle rescue response with Bothell Fire in front of the Home Depot. Ladder 131 was assigned extrication as the patient was trapped in the vehicle. I'm proud to report the patient was extricated 13 minutes after the time of the call; and within 6 minutes, 35 seconds after Ladder 131 arrived on scene. The patient was transported to Harborview Medical Center by Medic 142 with serious injuries. On August 24 Ladder 131 and Battalion 131 responded on a commercial fire with Sno. Co. #7. On September 7, Engine 131, Engine 135, Aid 131 and Battalion 131 responded with Bothell Fire on a multi-family structure fire. The fire was contained to a single unit thanks to the automatic fire sprinkler system and quick actions from the crews on scene.

Budget

With the exception of the response operations overtime budget, staff currently has no concerns with the 2019 budget. There are two factors contributing to the overage. One is the overtime that was incurred during the snow event earlier in the year and the other is staffing vacancies, for which there are some associated salary and benefits savings. Staff is closely monitoring the overtime budget. The budget report for the period ending July 31, 2019 is attached for your review.

Staff has prepared a 2020 draft budget for the Boards review and consideration. More details will be presented at the Budget Workshop immediately following the Board meeting.

Personnel

We currently have one firefighter on alternate duty due to a duty-related injury. We also have one firefighter off line due to a non-duty related injury. The District's 3 new firefighters started the Fire Academy on Wednesday, September 11. Lieutenant Justin Ralph is an instructor at the academy.

Battalion Chief Bryce Riddell is retiring after 33 years of service on September 30, with his last shift scheduled for September 29. Firefighter Gib LaFontaine retired after 32 years of service on August 30; his last shift was August 26. We will honor BC Riddell and our other retirees at the District's award recognition night in early 2020.

We will be holding a promotional ceremony at your next regular meeting on Tuesday, October 1. Lieutenant Seth Merritt is being promoted to Battalion Chief and Firefighter Kurt McGowan is being promoted to Lieutenant. I'm also hoping to have our 3 new firefighters in attendance so we can introduce them to the Board.

Update on the New Ladder 131

The onboarding and associated driver training for the new ladder has been completed. I'm pleased to report the new Ladder 131 was placed in service on Tuesday, September 10. Deputy Chief Wallgren worked closely with Lieutenant Merritt, Firefighter Smith and Firefighter Mach to get the ladder outfitted. Captain Woods and driving instructor Kurt McGowan led the driver training piece. This is an excellent example of what we can accomplish when we work together.

Update on New Aid Cars

The 3 new Aid Cars are in production at Horton Emergency Vehicles and are on schedule to be delivered in early December.

Regionalization Discussions

The subcommittee is scheduled to meet on Monday, September 23 at Northshore Fire Station #51 to discuss both the administrative and response operations organizational charts.

North End Training Consortium

Talks continue to evolve with the north end training consortium with the staffs and Local leaders from Woodinville, Bothell, Northshore and Shoreline. The Chiefs, Deputy Chiefs and Local leaders met on August 13. The meeting was very positive. There is one item related to the City of Bothell and Bothell's Local that needs some additional discussion. They will be working off-line to resolve the issue and Chief Kroon will be reporting out on the status on Thursday, September 19 at our North King County Chiefs meeting.

Community Relations

Thank you to the Board for your support and participation on the Celebrate Woodinville pancake breakfast hosted here at Station 31. Special thanks to CSO Breault and Executive Assistant Frisch for all their work in coordinating an amazing community event.
