Duvall:

On November 27th the KCFD 45 Fire Commissioner unanimously approved an Administrative ILA with EF&R. This also includes the transition of two District employees who will fill EF&R's Deputy Chief and Emergency Manager vacancies effective 1/1/24. The EF&R Board will consider this for final approval at their December 14th meeting.

District 3 Townhall:
